REFUND, CANCELLATION and NSF POLICY: The deposit is non-refundable but transferrable to a new participant. There is a \$25.00 charge for checks returned for insufficient funds. In the event of a tour cancellation or individual cancellation it is Global Educational Tours' policy to refund all funds to our clients that we are able to recoup from suppliers.
